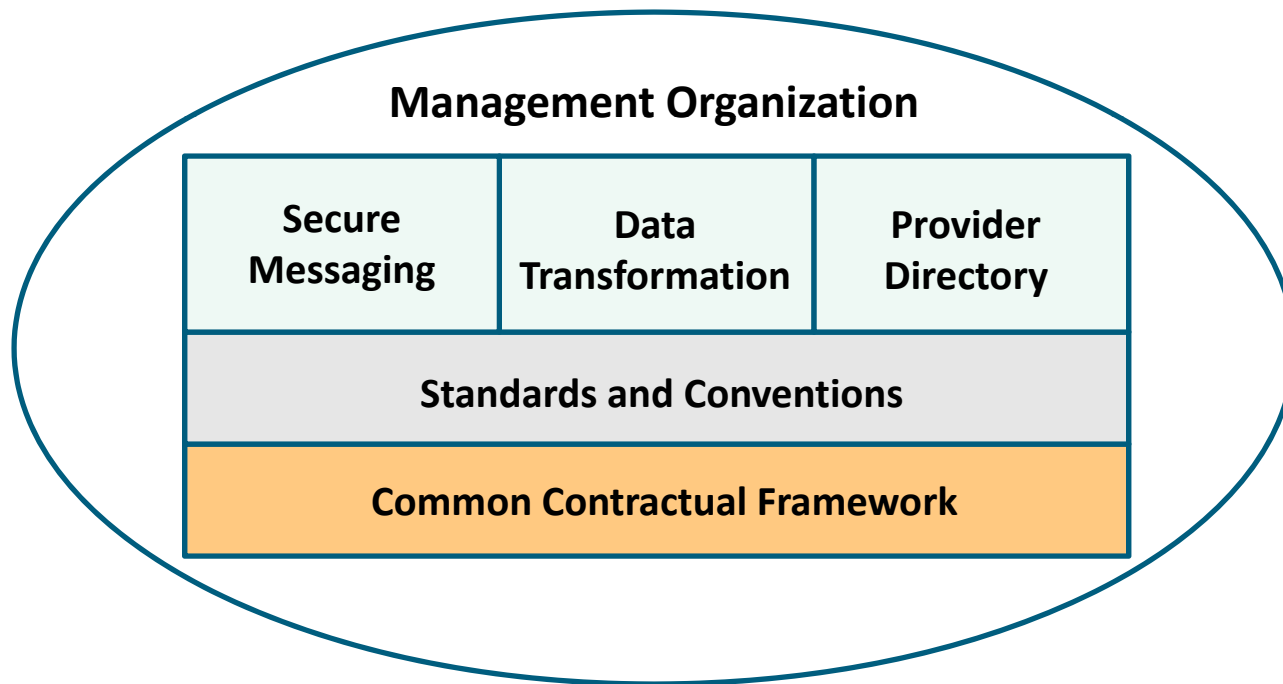

Initial Pricing – Reduce Early Adopter Risk

- Initial pricing model has three components:
 - One-time license fully subsidized by ARRA \$ for early adopters
 - Mapping costs will vary, some subsidy available
 - Annual subscription fee based on organization size – no transaction fees

Organization Level	Organization Description – SAMPLE Metrics	2011 Annual Subscription
Entry	Smallest orgs: revenue <\$10M, 1-9 practitioners	\$600
Small	Revenue \$10M - \$100M, 10-50 practitioners, <50 beds	\$6,000
Mid-size	Revenue \$100M - \$500M, 50+ practitioners, 50 – 500 Beds	\$12,000
Large	Revenue \$500M - \$1B, <500K insured lives, 500+ Beds	\$24,000
Leadership	Largest orgs: revenue \$1B+, 500K+ insured lives, 3,000+ FTE	\$48,000

Key Elements – Privacy/Security Model

- Driven by Thin-Layer, OneHealthPort lessons learned
- Built on modular common contractual framework
 - Common agreement between HIE and all trading partners
 - Core elements with optional service components
- Consistent with Washington State and federal law
- **Everyone is responsible within their own perimeter**
 - B2B model targeted at organizational trading partner
 - Organizations responsible for their individual users
 - Whatever consent is needed is secured by trading partners
 - Authentication/authorization handled by data/application owners

HIE Is Live – Ready For Trading Partners

- First seven transactions mapped:
 - Eligibility and benefits transaction (270/271)
 - ePrescribing (NCPDP Script standard 8.1)
 - Continuity of Care Document (CCD)
 - Lab results transaction (HL7)
 - Admission, Discharge, Transfer (ADT in HL7 format)
 - Radiology results reporting (HL7 format)
 - Immunization reporting and query (HL7 format)
- Recruiting Early Adopters
 - In contract discussions with a number of public and private organizations
- Provider Directory open to all
 - Whether or not you contract with the HIE
 - Contact, transactional info
